2017 COSGRAVE AWARDS DINNER A SUCCESS

On the evening of May 16, 2017, Finch alumnae, family, and friends gathered to honor the recipients of the 23rd annual Jessica Cosgrave Lifetime Achievement Awards, held at the Cosmopolitan Club in NYC.

FACULTY HONOREE

This year's faculty honoree was **Joann Catrino Rosenstrach**, who held several positions at Finch from 1965 to 1971, including business course instructor, Assistant Director of Admissions, and Educational Director of the Finch Intercontinental Study Plan (FISP). Joann

recalled that Dr. DeMarco referred to Finch junior year abroad as the "jewel in the crown." Besides discovering gelato, Joann "couldn't believe I was actually being paid for such an opportunity." However, Joann said her favorite position at Finch was "working in the Admissions Office with Sara Arthur, who is such a natural mentor," adding, "I was so proud to say I was from Finch when visiting other schools."

Joann recalled that she was at Finch during the turbulent '60s when "upheaval forced us to deal with the changes. It took courage and I like to believe it was the kind of courage Jessica Cos-

grave had." Joann reminded us also "that Jessica Cosgrave believed in the recurrent career." Joann is a good example, having attended law school at the age of 45. Joann's husband and children supported her decision, and Joann gave credit to her wonderful husband, Ivan Rosenstrach, for helping her balance work and family life. Specializing in real estate with a practice based in Mamaroneck, NY, Joann says "now, 31 years later, I am still in the game and I am happy for that." Joann and Ivan are the parents of three children, one of whom became a college admissions counselor, and the proud grandparents of six.

STUDENT HONOREES

Judy Kendall Levine

After spending her early years in Erie, PA, it was during high school in NYC that Judy discovered she “loved, loved, loved” New York. Judy has “current contact with about 20 Finch friends. By now they are more like sisters, and my Finch friends are truly a blessing.”

Judy spoke poignantly about one friend in particular, her college roommate, Judith Lamstein Charney, who was Judy’s maid of honor at her wedding. Tragically, Judith was killed in an automobile accident, leaving behind two small daughters. Judy spoke highly of these two very accomplished women, and one of Judith’s daughters, a psychologist with the NYC police force, attended the awards dinner.

Judy is a powerful presence in NYC in many areas: as a realtor, interior designer, philanthropist, and location scout with the Mayor’s Office of Film, Theatre and Broadcasting. As a fourth-generation member of prominent developers and investors, Judy brings her business acumen to her real estate business. After taking classes at the New York School of Interior Design, Judy opened her own firm and was a frequent designer at the Kips Bay Decorator’s Show House. Judy’s philanthropic passions have included involvement with the Anti-Defamation League’s Candlelight Ball and the Pediatrics Department at New York Presbyterian Hospital-Weill Cornell Medical Center.

Judy is the proud mother of two sons. Ross is a producer of film and music videos, including one with Beyoncé. Jonathan, a Hollywood film director and writer, whose recent film *Snatched* starred Goldie Hawn and Amy Schumer, made a special trip to fly in and attend the Cosgrave Awards dinner. Judy is also a doting grandmother of two.

Ginger Runes Kiernan Najar

“I am so proud to be a Finch girl,” Ginger beamed from the podium at the awards dinner. “Little did I realize that the women I met would become lifelong friends. I graduated from Finch on Saturday and got married on Sunday. It was the expectation of the era.” Ginger added, “most important, I am blessed with three fabulous sons and five perfect grandchildren!”

Two decades ago, Ginger created an innovative company called Reel Books, selling books about films in movie theatre lobbies. Ginger now continues the work of running the Philosophical Library, founded by her parents, who left Vienna in 1932 with only “their intellect and determination” and a “mission to publish the great works of the European intellectuals who my parents knew and admired.” Ginger’s father was Romanian-born philosopher and scholar Dagobert D. Runes.

Keeping current in the digital era, Ginger is expanding and converting 2500 titles into eBook format, and also releasing adult coloring books in a “Coloring with the Great Thinker” series. Echoing Jessica Cosgrave’s mission, Ginger reminded us that “as humans we must accept change and do our best to thrive in it, but as women we must continue to challenge and change the world.” Ginger concluded by stating, “I am thrilled to receive this award and thrilled to be in the company of my friends and, best of all, my sons.”

Ginger graciously left books on each dinner guest’s seat, including works from the library’s 22 Nobel Prize winners and history’s greatest thinkers, including Albert Einstein and Simone de Beauvoir.

Nancy Ellison Rollnick

Nancy, a second-generation Finch alumna, is enjoying a varied career. Having studied paint-

ing and art history, Nancy said “I had some very inspiring teachers at Finch, and Dr. Marshall Mount brought with him the world of African Art.” Nancy is an award-winning photographer whose work has appeared in *Life*, *Vogue*, and *Vanity Fair* and whose subjects have included Mick Jagger, Tennessee Williams, Boris Yeltsin, Jack Nicholson, and many more. When she was assigned to such far-flung places as Borneo and the Arctic Circle, Nancy exclaimed that she “couldn’t believe this was happening to me.” Nancy’s favorite photograph, however, is the one she took of her daughter, during her own delivery, describing it as the first selfie! Besides publishing 14 books, Nancy also produced numerous notable plays on Broadway, including a revival of *Inherit the Wind*, which received a Tony nomination. Nancy and her husband, William Rollnick, co-chaired the International Red Cross Ball at Mar-a-Lago three years in a row. Speaking as a photographer, Nancy stressed it is “important to not lose focus.” Nancy enthused that she’s “happy I have lived the life I have, married to the man I am, and it’s still happening. I just signed a book deal today!”

Dorothy Peterseil Tananbaum

Dorothy has devoted her life to art and philanthropy, as a principal for many years in the Vanderwoude Tananbaum Gallery, specializing in 20th-century art, and working tirelessly with many Jewish philanthropic causes, particularly focusing on the Holocaust. Dorothy is currently a board member of Facing History and Ourselves, an organization that trains teachers around the world to help students understand what it means to be an “upstander” rather than a “bystander.”

Dorothy recalled that Jessica Cosgrave had a dream to create a school that would “emphasize practical education. She developed a curriculum that offered liberal arts but also taught

women how to convert that liberal arts education into financial independence. No head in the clouds ideology for her.” Dorothy interned under Elaine Varian at the Finch Museum of Art, which Dorothy described as “truly one of the jewels of NYC.” Dorothy expressed that “what we learned in Finch was that just being is not enough. You have to do and you have to give. The Freya Moskowitz Stern Scholarship in her memory certainly highlights this value.”

“I was fortunate to have a living female hero from the very beginning of my life. My mother, Esther Peterseil, here tonight, is a survivor of the Holocaust, of the Auschwitz/Birkenau concentration camp. Finch College was the education that the Nazis denied her. Yes, for me, Finch was an entrée into a world I loved, but for her it was a taste of the next world she never thought possible. I am glad the legacy of Finch lives on. Finch alumni through these scholarships are continuing the vision of what this college was founded to do.”

Dorothy has three children and two grandchildren, and she and her husband Andrew live in NYC. Dorothy’s 93-year-old mother also lives in the same building.

Toni Tucker

After graduating from Finch with an Associate’s degree, Toni returned to school many years later, obtaining a BA with honors from Marymount, doing homework at the same time as her children! Toni spent a further year of study at the International Center of Photography and was a “personal photographer to an Indian guru, traveled the world with her, and it changed my life. My life has been beyond exciting!” Toni’s photographs have appeared in countless magazines and books, including a book called *Zen Dog*. Toni also found time to be a writer, news editor, and field producer with Channel 5 News and a press officer for Senator Gary Hart and Governor Mario Cuomo.

Toni is passionate about dogs: Her bichon, Porter, won best in breed at the Westminster Dog Show and her toy poodle was number one in the country. Combining her love of dogs and children, Toni was involved in setting up a pet therapy program for sick children at Morgan Stanley’s Children’s Hospital at New York Presbyterian. Dividing her time between New York and the Berkshires, Toni is the co-founder and publisher of

Berkshire Style, an online resource magazine for the area. Toni, the mother of two and grandmother of five boys, recalls “one of the great strengths at Finch was having access to all these wonderful people in NYC. I am grateful to Finch College for launching Jessica Cosgrave’s concept.”

Sidonia “Sid” Dalby Guest Speaker

Sid is the Associate Director of Admissions and advisor for the Ada Comstock program at Smith College, a program that enables women of non-traditional college age to complete a Bachelor of Arts degree, either part-time or full-time. Appreciative of the support the Finch Foundation has offered students, Sid said “I want to thank you all for understanding the needs of non-traditional students.” Sid read several quotes from students grateful for their Finch scholarships, saying how much it meant to them and made a difference in their lives.

Sid enjoyed her first visit to the Cosmopolitan Club and said “When Lois Ziegler invited me, I Googled the site and learned that Willa Cather, an author I love, was a member, as well as Eleanor Roosevelt. So I want to begin and end my talk with quotes from each of them.” Sid selected this quote from Willa Cather: “Where there is great love, there are always miracles.” And from Eleanor Roosevelt: “Never mistake knowledge for wisdom. One helps you make a living and the other helps you make a life.”

Sid concluded by saying, “I think Smith is very wise to have the Ada Comstock Scholars Program and I think the Finch Foundation is very wise to support deserving non-traditional women who are earning college degrees. Thank you from the bottom of my heart.”

Razieh Arabi: transferring from Queensboro Community College to Baruch College

At age 20, Razieh's family sent her to the United States to marry an Iranian-American citizen. Since his career came first, she quickly realized he would not support her pursuit of education. When their son was one year old, she left her husband and found a job working nights and weekends at Bloomingdale's. Her first triumph came when she was promoted to business manager; this major event made her realize that she would need to further her education in order to be offered further opportunities. Today, 15 years later, she is attending Queensboro CC in New York, in addition to living with and taking care of her son and her parents who just moved to New York.

Razieh enjoyed the study group she created with classmates. When she ran for student government, she was elected treasurer and delegate to the CUNY University Student Senate, and she is a member of Phi Theta Kappa (PTK). She also joined the Fed-Challenge team, in order to learn all about the Federal Reserve System and the economy. She is currently a semi-finalist in the CUNY & Community College Innovation Challenge program where she can develop a business hypothesis. During spring break this year, she participated in the Global Citizen Alliance, an intense weeklong study abroad program in Salzburg, Austria. She looks forward to getting a Bachelor's Degree in accounting and finance at Baruch College.


THE LOIS CHILES SCHOLARSHIP

This past summer, by attending a PTK International Honor's Institute at Wake Forest University, she experienced dorm life while attending various workshops. Actively involved in Broome campus life, Heather participates in the food pantry, the Parking Appeals Committee, and, as part of the Women's Discussion Group, has donated 116 books to the Women in Prison Project. Her blog, Civic Voices of Democracy's Students, set to publish next May, was designed to inspire and reflect those administrations and students that are going above and beyond the call of duty with service-oriented projects. Now age 26, Heather, until recently, cared for her mother who finally succumbed to cancer. 
Carolina Dellepiane: transferring from Borough of Manhattan Community College to Smith College

Although Bergen CC opened a food pantry for students, few actually took advantage of it, since the students were ashamed of the pantry's visibility. Entering Bergen CC, she began to step out her comfort zone, to become a leader and build self-confidence. Today, she is a member of PTK, was named a national Distinguished Chapter officer, and was elected to one of only five international officer positions in the PTK Honor Society. She looks forward to attending Pharmacy School at Rutgers University for personal fulfillment, as well as to impact the lives of others. The Finch scholarship will enable her to buy a new computer as well as pay part of her rent.


THE DR. MARGARET MAXWELL SCHOLARSHIP



Hassana Falal Idriss: transferring from Borough of Manhattan Community College to Long Island University, Brooklyn

Although having surgery as a child in Ghana, West Africa was a frightening experience, it was meeting compassionate and caring nurses that fostered Hassana's dream of becoming a nurse. One young nurse in particular inspired her to want to make people comfortable and happy. Today she is determined to achieve her dream and serve her fellow citizens. Working part time for tuition and books, Hassana also enrolled in Borough of Manhattan CC, focusing all her energy on education and receiving a degree. She has a GPA of 4.0 in nursing prerequisites, is a member of PTK Honor Society, and was asked by the learning resource center of her school to be a supplemental leader for other biology students. She is excited by the prospect of entering the premier nursing program of Long Island University's Brooklyn campus to earn a Bachelor's Degree. Her scholarship came at just the right time, she says, and it will be applied toward tuition and lessening her part time work hours. Becoming a nurse will provide her the financial means to support her mother. The Dr. Margaret Maxwell Scholarship, which honors the Finch history professor for whom it is named, is awarded to a scholar who has overcome adversity.

Huibin Liu: transferring from Queensboro Community College to Baruch College

Huibin is from a traditional Chinese family in which a girl's education is not considered to be important. Her parents' dearest wish is for her to marry, have children, and help her husband support the family. At age 28, she was earning a high enough salary in China to support the family, working in HR. When the family migrated to the United States, not speaking a word of English, she got a waitress job in a Japanese restaurant to support her mother and brother. Believing in the importance of a higher education, she enrolled at Queensboro CC. Her first semester advisor suggested business administration as a major, and she quickly discovered she had an aptitude for math, particularly for analyzing data and solving mathematical problems. While solving analytical problems came easily to her, mastering the English language became a struggle. Therefore, she participated in discussion groups and enrolled in courses in the humanities, social sciences, and history. These basic liberal arts and science studies were vital if she were to transfer credits to Baruch College, which had become her

goal. She has participated in the Emerging Leaders Program and was senator of the Asia Society Club, planning events, all of which have helped develop her leadership skills and mastery of English. Her goal is to gain a Bachelor's and Master's Degree in the science of statistics in order to become a statistician.

THE DOROTHY PETERSEIL TANANBAUM SCHOLARSHIP



Yehides Moskovits: transferring from Rockland Community College to Columbia University

Raised in an ultra-orthodox Jewish community, Yehides lived by the strict guidelines of sheltered family-centric values: girls were groomed for marriage to a husband chosen by her parents, and were to raise a large family immediately. Two years after high school, Yehides was married for one tremendously difficult year before moving back home. One good thing is that she enrolled in Rockland CC at night, while her husband looked away as she also worked full time. Diving enthusiastically into her studies, she discovered biology and chemistry for the first time. An anthropology class sparked her interest in studying diverse people of the world. As a humanities major with a love of science, she thinks of herself as a paradox. She has been selected a semifinalist for the prestigious Jack Kent Cooke Memorial Transfer Scholarship and was honored with the SUNY Chancellor's Award for Student Excellence. Her life has been enriched with new friends and mentors. While she was also accepted at Johns Hopkins University, Yehides will attend Columbia University to study Anthropology and work on completing pre-med prerequisites, with a goal toward becoming a pediatric surgeon.

Asia Luna Ntampuhwe: transferring from Erie Community College to Binghamton University

Originally from the Democratic Republic of Congo, Asia, along with her mother and five siblings, fled a political war and sought refuge in Kenya, where they were given a second chance.

Language was a major barrier as English became the new language; the family became excellent writers and speakers. They lived with refugee status, which meant applying for financial aid through UNHCR. To this day, she is forever grateful for the help provided by a private sponsor, which enabled her to study and complete her primary school education, with excellent grades. A different scholarship enabled her to attend one of the best Kenyan high schools. At this high school, she improved in social interaction, and developed a deep love for community service. Two years ago, Asia and her family arrived in the US on a refugee visa and she enrolled in Erie CC at the first chance she had. Being a member of PTK Honor Society helped expose her to community outreach, great scholarships, and leadership opportunities. She became part of a group of students that organized a Thanksgiving dinner for the homeless. At Binghamton University she will pursue an Actuarial Science degree. Asia credits most of her educational progress to the many folks who have willingly given support to her in time, mentorship, money, and energy. Aspiring to be a youth mentor, Asia is passionate about personal growth through mentorship.

Mariem Tolba: transferring from Norwalk Community College to Baruch College

Mariem is from Mauritania, a small country in northwest Africa where tribes and family names play a huge role in social order. Her family is a member of the Dawaali tribe, one of the largest and most respected tribes, primarily because of their emphasis on education. Being a “Toba” girl immediately brought respect. At age 13, her family moved to the capital, Nouakchott. It was difficult, as no one knew her tribe and she had to adjust and create her own identity. When she came to the US in 2013, she had an opportunity to start her education anew. Not speaking

English, she enrolled in the English as a Second Language (ESL) program at the University of Bridgeport. A year later, she entered Norwalk CC, majored in Accounting, and was impressed with clear, precise, unified regulations to record a company’s transactions. She cannot wait to learn more and have enough knowledge and experience to open an accounting firm in Mauritania to help reduce the enormous amount of fraud cases. Entering Norwalk CC, she immediately became involved in the Peace Club, community service, collecting clothes, and raising money for refugees. She joined a Model United Nations Club, the Accounting Society, and the PTK Honor Society. She has tutored fellow students and received the Woman of Promise and Distinction Award. The past two years have changed her life and she looks forward to attending Baruch College to complete her degree in accounting.

Despite her modest beginnings, Aquella has always been optimistic about her future. She does not live with or speak to her mother, who has no interest in understanding the educational journey her daughter has undertaken. Proud of her Associates Degree from Westchester CC, Aquella believes that, with perseverance and optimism, she has a good chance to succeed. She is now actively engaged in various campus activities, has had a 4.0 GPA each semester, and worked part time for the State Society of Public Accountants. She received the 2017 Curriculum Award in Accounting, and takes great pride in her prospective career as an accountant, seeing herself as a future CPA. Accounting has provided the stepping-stone to greater awareness of the world around her. Says Aquella: “Words cannot express the gratitude I feel knowing that a prestigious panel of college professors read my essay, took note of

IN MEMORIAM

As this newsletter went to press, we learned of the loss of devoted Finch alum, newsletter contributor, and supporter, **Laura Hockaday**, of **Kansas City**. **Laura led a fascinating life, which will be celebrated in the manner it deserves in our next issue.**

IN THE SPOTLIGHT: EILEEN BLUESTONE SHERMAN

Award-winning playwright, lyricist, young adult novelist, and theater and music producer, **Eileen Bluestone Sherman**, found a way, early on, to channel and combine her passion for the arts and education.

Just five days after graduation after four years at Finch as a Theatre Arts major, Eileen Bluestone, who grew up one block from the ocean in Atlantic City, New Jersey, married her high school sweetheart, medical school student Neal Sherman. After a one-night honeymoon, they left for upstate New York, so Neal could attend school at Albany Medical Center and Eileen would receive a Masters in theatre from SUNY/Albany. It was during this time that she began developing musical theatre for preschoolers and took her first job, at the Jewish Community Center at Albany.

After Neal's graduation from medical school, the couple spent three years in Danbury, Connecticut for Neal's residency. During this time, they also became new parents. Following residency, the family moved to Kansas City, Missouri. It was there, while perusing *The Kansas City Star* newspaper, that an audition notice for a new children's theater, The Coterie, sponsored by Kansas City-based Hallmark Cards, caught Eileen's eye. With daughter, Jenny, now enrolled in Montessori preschool, and two-month-old son, Joshua, at home in the afternoon with his nanny, Eileen decided to audition with a story she had written a couple years earlier, hoping to turn it into a picture book. Despite rejection by every publisher to whom she had submitted it, she held on to the manuscript. Since the story was originally written in long poem form, Eileen set to work editing and adapting one particular section that she thought could serve well as a suitable audition piece. Her hunch paid off, for, after the audition, the director asked her where she had found the monologue. When Eileen explained that she had, in fact, written it herself, the director hired her to write for The Coterie.

Eileen's first musical for The Coterie was *Me, Myself, and I*, a play consisting entirely of vignettes about growing up. The director had requested a script in the style of the then-popular children's entertainment project, *Free To Be You and Me*, by Marlo Thomas. One of the scenes from her first play inspired Eileen's second musical for The Coterie, *Rotten Apples*, for which she wrote the book and lyrics and for which her sister, Gail, wrote the music.

This happened in 1984, the same year Eileen's picture book, *The Odd Potato*, was published. When she first saw the illustrations of artist Katherine Janus Kahn, Eileen immediately thought the book could be adapted as a family-friendly musical, and that it would be a perfect fit for Jewish Community Center theaters nationwide. After reaching out to the directors of these theaters, 30 JCC's around the country ended up

staging the musical, which, once again, was created by the Bluestone Sisters.

Move Over, Blues Brothers - Here Come the Bluestone Sisters!

The Odd Potato was inspired by the story of their dad's childhood during the Great Depression. Originally created as a picture book by Eileen, the Bluestone Sisters' musical television adaptation received an Emmy Award in 1990, and in 1994, *The Odd Potato* was produced at New York's Merkin Concert Hall. In 2003, the musical was presented at Symphony Space in Manhattan as *Broadway Sings the Odd Potato*, starring Frank Gorshin and Charlotte Rae, with direction and choreography by four-time Tony nominee, Randy Skinner.

Knowing full well that the show would need an album or a CD, Eileen partnered with Variety The Children's Charity in Kansas City, where she found the perfect hook: "Tony Award Winners Sing Out for Variety's Kids." In 2005, Eileen and her son, Josh, produced *The Odd Potato: The Broadway Album*, starring 20 Tony Award winners including Sutton Foster, Elaine Stritch, Hal Prince, and others, and narrated by Judd Hirsch, to benefit Variety the Children's Charity of Kansas City. The show's "One More Day," recorded by Hal Linden, received a Global Music Silver Medal Award for "Best Traditional Pop Single." Although the album did not receive a Grammy nomination, it firmly established Eileen as an official Grammy voter, and she has been an active member of the Recording Academy ever since.

Last Fall, Gail and Eileen were the featured songwriters at Broadway's Future Songbook Series at Lincoln Center, with an all-star Broadway cast for their concert musical, *Perfect Picture*, which made its debut that same evening. The show, about iconic American artist, Norman Rockwell, was presented at Hallmark Cards' Crown Center in Kansas City in February 2017, as a benefit performance for the National Council of Jewish Women of Greater Kansas City. (The "All Broadway" studio cast recording is available at www.cdbaby.com.) The studio cast album, *Perfect Picture*, also received the Global Music Silver Medal Award for "Best Musical Theater Album." (Finch alums may remember attending a performance of an early version of *Perfect Picture* at the Blue Heron Theatre, which was led by Finch professor and mentor, **Dr. Ardelle Striker**.)

In 2016, the sisters' "A Child's Dream Will Light the Way," recorded by Tony and Emmy Award winner Lillias White, debuted on UNESCO's world peace album, *Action Moves People United*, and received a Global Music Silver Medal Award for "Best Gospel Song."

Eileen and Gail's songs are also featured on the musical web series, *Charmers*. Their song, "I

Keep Christmas in My Pocket," also performed by White – this time, as the "Christmas Loon" – earned them a 2017 Hollywood Music in Media nomination for holiday music. (The winners will be announced this November.)

In Spring 2018, the women's latest song, "Stand Up Proud," will be released as a single and will serve as the musical theme for the debut of The Four Freedoms FestivalSM, scheduled for Summer 2018 in Arlington, Vermont.

Eileen is also a prolific book author. Her award-winning young adult novel, *Monday in Odessa*, received the National Jewish Book Award; *Independence Avenue* received the International Reading Association's Teachers' Choice Award; and *The Violin Players* earned a Thorpe Menn Honorable Mention.

This Fall, Eileen will begin her 20th year as an adjunct faculty member at Baker University, teaching dramatic literature online. She recently co-founded - with the award-winning indie artist Grant Maloy Smith - The Indie Collaborative, a group of award-winning independent ("indie") music artists from all over the globe, which fosters new and unique musical collaborations. It is fast approaching the 1800-membership mark worldwide. For more information about Eileen's future projects, visit her website, EBS Originals, at www.ebsoriginals.com.

Eileen and Neal Sherman have been married nearly 45 years. Daughter Jenny heads her own law firm where she practices commercial real estate and entertainment law. Son Joshua - a physician (like his dad) and a theater and music producer (like his mom) - is currently creating an entire complex for the arts (theater, music, dance, art, film, and literature) in Arlington, Vermont. Six-year-old granddaughter, Allegra, is a first grader, and Eileen's biggest fan!
